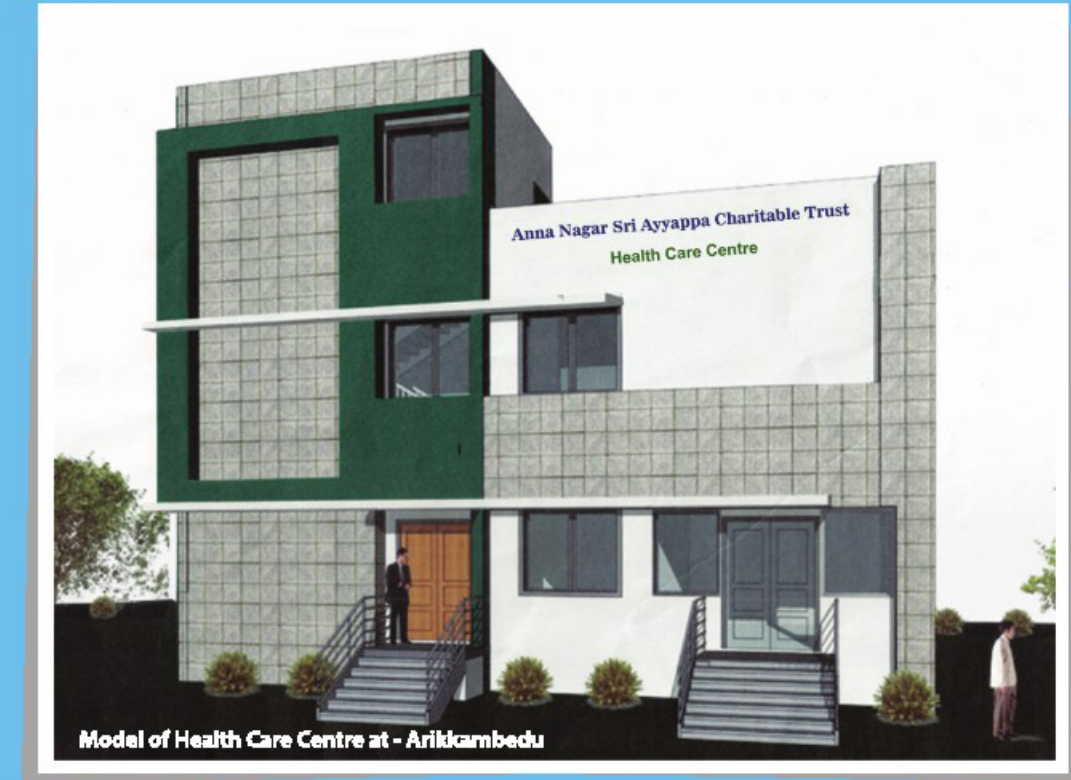

## AN APPEAL

Sri Ayyappa Seva Samajam which is running the famous Sri Ayyappa Temple at Anna Nagar, with over three decades of Religious, Cultural and Charitable activities to its credit, is a household name for the enlightened public of Anna Nagar and the neighbourhood.

Realising our social responsibility, need for more focussed charitable activities was felt and accordingly it was decided to form a Public Charitable Trust. Subsequently, Anna Nagar Sri Ayyappa Charitable Trust was registered on 18/03/2011.

Ever since the formation of the Trust, all charitable activities of the Samajam are managed by the Trust.



### MEDICAL ACTIVITIES

We have two Health Care Centres, one at Mogappair East and the other at Arikkambedu, near Avadi, where free treatment is given to patients. During the financial year 2011-12 more than 12,000 patients were offered free consultation, treatment and medicines. The number of patients increased to 13,000 during the financial year 2012-13. Three well-qualified and experienced Doctors and other para medical staff are taking meticulous care of the patients coming to the Centres. The Trust is incurring a substantial annual expenditure in running the health care activity.

The Trust is in possession of seven acres of land at Arikkambedu, near Avadi and four grounds at Mogappair East. A new building for the Health Care Centre is nearing completion at Arikkambedu at an estimated cost of Rs. 1 Crore.

### DIALYSIS CENTRE

One of the major activities of the Trust will be the establishment and running of the most modern Dialysis Centre at our Mogappair Centre. The building plan for the Dialysis Centre is also prepared by our Architects M/s. C R Narayana Rao and the same is under scrutiny. The construction work will be started immediately after getting the plan approval. Our Dialysis Centre will be equipped with most modern machines and we propose to run it as a prestigious and state-of-the-art Centre which will be unique in nature, compared to other Centres operating in the City. The estimated project cost will be about Rs.10 Crores and when completed, it will provide satisfactory services to a large number of patients, affected by renal disorders, from all sections of society at affordable cost. We are overwhelmed by the response from philanthropists and well-wishers, who have already volunteered to donate the cost of 4 Dialysis Units, initially.



### EDUCATIONAL ACTIVITIES

We have extended educational assistance to a large number of students from various schools in Chennai, as recommended by School Principals, on merit-cum-means basis, during the Financial year 2011-12 & 2012-13.

It is proposed to start a CBSE school at Arikkambedu. The school when completed will impart quality education at affordable cost to the children of the surrounding areas. The first phase of the school project is estimated to cost of Rs. 5 Crores.

### SCHOOL UNIFORM / CLOTHES

We are regularly distributing Uniforms/Clothes to students and inmates of the Guild of Service, Anna Nagar West, Chennai, Tamilnadu Social Welfare Association, Arumbakkam and Balvadi, Mogappair East, Chennai.
